

Aksel Lund Svindal Nominated as Chairman of the Board at Airthings

Geir Førre Continues as a Board Member and Qualifies the Move as Strategic

Førre, who is also the current Chair at several companies, including Disruptive Technologies and Zivid, will continue as an active member of the Board of Directors at Airthings working closely with both Svindal and Airthings' CEO Øyvind Birkenes. "After working for many years with both Geir and Aksel, I can state with certainty that we are a strong, winning team," said Birkenes. "We have ambitious goals for Airthings and together we'll continue to drive success for the company."
