The Nomination Committee's proposal to the extraordinary general meeting in Airthings ASA

The nomination committee in Airthings ASA (AIRX) consists of the following members:

Since the annual general meeting in May 2025, the nomination committee has received input and held meetings with some of the largest investors in the company who has been looking to make changes to the board composition.

The nomination committee's decisions on proposed candidates to the board have been unanimous.

Election of shareholder elected members of the board

When developing its proposal, the nomination committee prioritized ensuring that the Airthings board remains diverse and encompasses a broad range of relevant skills and experience, while placing particular emphasis on input from shareholders whose collective feedback has consistently called for stronger shareholder representation on the board.

The committee recommends keeping the current number of external board members for the upcoming term.

The nomination committee believes that the proposed changes will ensure the board continues to represent all shareholders effectively and meet the company's requirements for expertise, capacity, and diversity. The proposal also complies with the Oslo Stock Exchange's requirements and the Norwegian Code of Practice for Corporate Governance regarding board member independence.
